Montgomery GI Bill Select Reserve — Chapter 1606

Eligibility

- ✓ 6 yr. contract or OSA
- ✓ Completed IADT

Benefit

- Monthly Housing Allowance (MHA):
Full Time = \$367.00/mo
¾ Time = \$274.00/mo
½ Time = \$182.00/mo
< ½ Time = \$91.75/mo

Length

36 School Months

Expiration

At the time the Service Member drops into the Incremental Ready Reserve (IRR)

Reserve Education Assistance Program — Chapter 1607

Eligibility

- ✓ Reservist/Guard member
- ✓ Served at least 90 consecutive days on Active Duty (AD)* after 9/11/01:

90 days	=	40%
1 year	=	60%
2 years	=	80%

*Must be consecutive and qualifying Congressional or Presidential Title 10 orders.

Post 9/11 GI Bill — Chapter 33

Eligibility

- ✓ Served at least 90 days on Active Duty (AD)* after 9/11/01:

| 90 days | = | 40% |
| 6 months | = | 50% |
| 1 year | = | 60% |
| 1 ½ years | = | 70% |
| 2 years | = | 80% |
| 2 ½ years | = | 90% |
| 3 years | = | 100% |
- *Must be qualifying Title 10 AD time (12301a, 12301d, 12301g, 12302, or 12304).

Benefit

- Tuition and Fees (paid directly to school)**
 - Book & Supply Stipend**
 - Monthly E5-BAH w/dep.**
- **% rate determines amount of Benefit paid

Expiration

15 years from the last day of Active Duty

Montgomery GI Bill Active Duty — Chapter 30

Eligibility

- ✓ Completed at least 2 years of Active Duty contract
- ✓ Honorable Discharge
- ✓ Paid \$1200 into program
- ✓ Never voluntarily declined GI Bill

Benefit

- Monthly Housing Allowance (MHA):
Full Time = \$1717.00/mo
¾ Time = \$1287.75/mo
½ Time = \$858.50/mo
< ½ Time* = \$858.50/mo
< ¼ Time* = \$429.25/mo
- * Tuition and Fees ONLY. Payment cannot exceed the listed amount.

Length

36 School Months

Expiration

10 years from the last day of Active Duty

Vocational Rehabilitation — Chapter 31

Eligibility

- ✓ Service Connected Disability (SCD) of 10%
- ✓ Memorandum of 20% from VA
- ✓ Applied and accepted by VocRehab & Employment (VR&E) services at VBA Regional Office (see VR&E Caseworker for more details)

Benefit

- Full Tuition and Fees Cost
- Full Book and Supplies Cost
- Monthly Subsistence Allowance

Length

48 School Months

Expiration

12 years from the date of entitlement
