The instructional program prepares individuals to care for hair, nails, and skin with emphasis on hygiene, sanitation, customer relations, and salon management. Satisfactory completion of the courses qualifies students for the Mississippi State Board of Cosmetology certification examination. Admission to the program is on a competitive basis. This program requires 1500 clock hours for completion. Students are only accepted during the fall semester on the Senatobia campus. Students are accepted both fall and spring semesters at the Oxford and Ashland campuses.

ADMISSION REQUIREMENTS:

- Applicant must be at least 17 years of age.
- Must be a high school graduate (diploma) or have passed the GED.
- You must have a Northwest application on file with the Registrar's office. (App link)
- You must have a Cosmetology Program application on file with the appropriate campus. (Cosmo App link)
- You must have an official G.E.D. equivalency or official high-school diploma on file with BOTH the Registrar's office and the Cosmetology Department.
- Applicants must complete and obtain the required scoring on the Test of Adult Basic Education (TABE)
- Any interested person should contact the Cosmetology department at the campus of choice.
- You must be able to perform all requirements and meet State Board Standards. (Link to state board standards)

- Maintain strong attendance.
- Take and pass the Mississippi State Board of Cosmetology examination.
