I. CALL TO ORDER/REVIEW AGENDA:

Dr. Heindl called the meeting of the November 4, 2020 Executive Council meeting to order.

Dr. Tonyalle Rush made a motion that the Executive Council approve the agenda for the Executive Council meeting dated November 4, 2020. The motion was seconded by Dr. Carolyn Wiley.

II. APPROVAL OF THE EXECUTIVE COUNCIL MINUTES:

Dr. Don Jones made a motion that the Executive Council approve the minutes of the Executive Council meeting dated September 30, 2020 as presented. The motion was seconded by Mr. Dan Smith and carried unanimously.

III. REVIEW OF ACTION TRACKER ITEMS

IV. AGENDA ITEMS- Dr. Heindl

A. Updates

Dr. Heindl reminded the Executive Council that November 18, 2020 Northwest will hold a Thanksgiving: Breakfast, Brunch or Lunch for all employees in the Haraway Center, Room 102.

Dr. Heindl reviewed the Legislative Priorities for FY 2020-2021.

- 1. Restoration of FY 2021 Reduced Appropriations-\$6,658,703
- 2. 5% Funding Formula Increase-\$10,000,000
- 3. 3% Salary Increase for Community College Employees-\$10,000,000
- 4. Career Technical Education- \$10,500,000
- 5. Dual Credit Scholarship Program- \$25,000,000
- 6. \$35 Million in Capital Improvement Bonds per year- \$35,000,000

V. AGENDA ITEMS – Mr. Smith

A. Updates

Mr. Smith reported that on December 1, 2020 Northwest will host a Legislative Luncheon in the Haraway Center, Board Dining Room.

Mr. Smith shared that on December 10, 2020 following the Board of Trustees monthly meeting there will be a Ground-Breaking Ceremony for the new Performing Arts Center at the site.

Mr. Smith shared that they will be meeting with the Board of Supervisors in Tallahatchie County in December the date is TBD.

A. Update

Dr. Domas reported on the Barksdale Reading Program sharing that a survey has been sent out to the students that have been enrolled in the Developmental Reading course.

Dr. Domas shared that on Saturday, November 7, 2020, Northwest will host the annual Bull-o-Rama. Tickets will be available on Thursday, November 5, 2020.

Dr. Domas shared that on Saturday, November 7, 2020, Northwest will be playing Mississippi Delta Community College at Moorhead, MS. The game begins at 2 pm.

Dr. Domas shared that all the volleyball games are being recorded and you can find them on the Northwest YouTube channel.

Dr. Domas reported on the Choir Concert that was held on Monday, November 2, 2020 in the Fine Arts Auditorium. He noted different stylistic techniques that are being used now as compared to a year ago.

VII. AGENDA ITEMS- Mr. Horton

A. Update

Mr. Horton shared with the group that the revenue regarding tuition is down 4% to budget. The fees are tracking on pace. This year to last year the budget is down \$162,000. Typically, the spring semester lags behind the fall semester. By location: Senatobia is down \$320,000, Desoto is down \$836,000 and Oxford is down \$293,000. The scholarships compared to last year are flat.

Mr. Horton reported on the following information:

- Technology Grant- This project planned for 1,000 students to receive a device package. Over the last 2 weeks 733 students have come to the Senatobia Campus and picked up their awarded device package in the bookstore. There will be some shipped to the Southaven and Oxford bookstores to make it easier for students who have been awarded to pick up the devices.
- o Reviewed the CARES Act Funds.
- Soccer/Softball Complex Project is expected to break ground in January 2021 with completion in the early fall 2021. The walking track will be closed January through August 2021.

Dr. Rush reported that the fall 2020 enrollment is down 6.6% and credit hour is down 7.1%. For the winter session there are 200 unduplicated students who have enrolled for that session. Dr. Rush is working closely with Communications to get more information out regarding this new semester. Looking towards spring semester there are currently, 1,336 students how have priority registered for this term.

Dr. Rush shared that Commencement is scheduled for December 11, 2020 at 10 am with a School of Health Science Pinning at 2 pm.
